

#### SSCA Member Jarrod Self Participates in SAMSHA Conference



Arkansas SSCA member Jarrod Self was invited to attend and participate in the SAMSHA (Substance Abuse Mental Health Services Administration) Lifted Lived Experience in Criminal Justice Settings Dialogue Meeting in Washington DC. As part of the conference, he was part of a panel discussion, The panel was made up of 5 corrections professionals. He says that he was happy to share about the programs in Arkansas, not just "Reentry" but all of Arkansas Corrections. Mr. Self commented "Arkansas is definitely ahead of the curve. Since the conference I have been in contact with various entities across the nation, sharing our success and failures with the common goal of reducing recidivism."

# Lt Jackson supervises Community Work Crew program At CACCC in Little Rock Arkansas



In 2014, Pine Bluff native Juliet Jackson was named a Southeastern Conference Legend as she became a University of Arkansas (UA) Hall of Famer. From 1986 to 1990, Jackson was an integral member of the University of Arkansas' two most successful sports teams.

During her freshman year, the Razorbacks won the Women's National Invitational Tournament, beating California 112-80 in the championship game. In her senior season, Arkansas beat Texas, ending their NCAA-

record 183-game conference winning streak and the nation's longest home winning streak at 47 games. Jackson aided in the Razorbacks' 82-77 win with four clutch free throws, which helped earn the team a 12-1 road record and a Southwestern Conference (SWC) regular-season title. That season, during the NCAA tournament, Jackson scored 30 points assisting her seventh-seeded Arkansas team to beat UCLA in overtime and upset the highly ranked Georgia team. Though Arkansas made the Elite Eight, they fell short of the Final Four, losing to tournament champion Stanford, 114-87.

During an interview with the Northwest Arkansas Democrat-Gazette, Jackson said, "I enjoyed all of my time spent (in Fayetteville). I would have to say my senior year was the best. It was the year we beat Texas to end their big winning streak and the year we went to the Elite Eight."

As a two-time SWC second-team honoree, Jackson is currently top 20 in Arkansas history in both points and assists. She ranks 11th in career assists with 313. She also averaged 10.1 points per game and scored 1,213 points making her 17th in UA career history.

Jackson's prolific basketball career did not start at the University of Arkansas, though. In 1983, Jackson met coach Jim Tyler while playing in a basketball game in Benton. According to Jackson, "He is one of the coaches that got me interested in playing AAU ball. That's what really changed my future." Thanks to donations made at Pine Bluff area banks, in the summer of 1984, Jackson and Tyler's Arkansas Angels AAU team played basketball in Sweden, Finland, and Norway.

After entering Pine Bluff High School, Jackson racked up numerous honors. In 1984, as a sophomore in track and field, she earned all-America honors in the 4x400 meter relay. In basketball, she was the Gatorade player of the year for Arkansas, a Parade Magazine All-American, and an All-American by the National High School Athletic Coaches Association. In 1985, Jackson earned Most Valuable Player of the 18-and-under national AAU Tournament in Fairfax, Va., after averaging 24 points per game for the Angels. Jackson is arguably the most decorated women's athlete in Pine Bluff High history.

Jackson coached AAU for six or seven years but had to give it up when she took a new job at the Arkansas Community Corrections facility in Pine Bluff. When asked about her time coaching AAU, Jackson said, "Through coaching AAU, I think I have given that much back to the community that it gave to me."





### Central Arkansas Community Correction Centre Starts Urban Garden



Staff and residents at the Central Arkansas Community Correction Center in Little Rock started an urban garden this year with the help of local businesses. Seed, compost, fertilizer and supplies were donated and the residents went to work. The garden produced potatoes, peppers, carrots, okra, corn, tomatoes, cucumbers, squash, and cantelope. All of the proceeds were consumed by our resident population. CACCC was also able to supplement our harvest with fresh produce grown at the Grimes Unit in Newport, AR. There we received additional cantelope, watermelons, and corn. The final picture shown above is a tray we were able to serve to the entire resident population that every ingredient, besides the beef, was grown on ARDOC land by inmates and residents. This photo was posted to FaceBook where it received almost 50,000 "likes", 4,200 comments and almost 6,000 shares from people and organizations all over the world.

### US Marshals arrest Arkansas escapee in West Virginia

WASHINGTON — The U.S. Marshals, along with West Virginia State Police, Lewisburg Police Department and Greenbrier County Sheriff's Office, this afternoon arrested at the Quality Inn in Lewisburg, West Virginia, a man who escaped from an Arkansas prison facility in 2022.

Samuel Paul Hartman, 39, an inmate at the East Arkansas Regional Unit, was sentenced to life in 2013 after being convicted of raping his 14-year-old stepdaughter, but he escaped on a work detail in a field near the detention facility.

Also taken into custody were Hartman's wife Misty Hartman, 39, his mother Linda Annette White, 61, and White's boyfriend Rodney Trent, 52, of Lester, West Virginia. Both women are alleged to have helped Hartman escape using a pickup truck and jet skis. Trent faces felony charges for allegedly harboring a sex offender and for assisting the trio while on the run.

While Hartman was on a work detail Aug. 12, 2022, a vehicle approached the work crew, and two women, later identified as Linda White and Misty Hartman, exited the vehicle and fired several shots toward the work crew as inmate Hartman ran to the awaiting vehicle. The vehicle then fled as DOC officers pursued. DOC pursued the vehicle to the area just short of the Mississippi river where all three fled to two pre-staged jet skis.

After a short time, law enforcement officers from Mississippi and Arkansas went to the Mississippi side of the river and located the abandoned jet skis on the riverbank. An eyewitness on the Mississippi side of the river reported seeing one man and two women riding jet skis across the river.

In March, USMS investigators from the agency's Cold and Complex Case Unit paired up with investigators from the Eastern District of Arkansas to find the three. Investigators developed information that Linda White had ties to West Virginia and contacted the Southern District of West Virginia for assistance in the case.

"Today's announcement is the culmination of a year of outstanding, dedicated work by our heroic law enforcement officers. Now that they have brought this dangerous fugitive to justice, all Arkansans can sleep safer at night," said Governor Sarah Huckabee Sanders.

"Today's capture was the result of deliberate and determined law enforcement work," said Joe Profiri, Secretary of the Arkansas Department of Corrections. "The United States Marshals Service, Arkansas State Police, and the Arkansas Department of Corrections have kept this case on the forefront and followed hundreds of leads over the course of the last year. We appreciate the support and assistance from all agencies involved, the Arkansas Governor's office, and the State of West Virginia in bringing this case to a successful conclusion."

"In my nearly 30 years of law enforcement, I cannot recall a task force that has the level of dedication to accomplishing the mission and making our communities safer than that of CUFFED (Cops United Felony Fugitive Enforcement Division Task Force)," said Michael Baylous, U.S. Marshal for the Southern District of West Virginia. "The apprehension of these dangerous fugitives demonstrates the close and outstanding relationship that CUFFED enjoys with our local and state partners, other USMS Districts, and the USMS Domestic Investigations Branch."

#### Kenneth Law Scholarship

#### **PURPOSE:**

The SSCA is a 14-state regional organization of correctional practitioners representing the operational and administrative areas of jails, probation, prisons, and parole. It is the intent of this scholarship award to financially assist individuals preparing to or already participating in an accredited college or university program of study.

#### PROCESS:

Each year individual(s) will be selected to receive the SSCA Scholarship Award. The process begins at the state level with applicants submitting application packages (form and attachments) to their respective SSCA State Representative no later than **April 1, 2024** These applications will be screened by a State-level screening committee and one primary and one alternate application will be forwarded to the SSCA Scholarship Award Committee for consideration. The Award Committee will select recipients and award scholarships in an amount and number to be determined by the Executive Board. Applicants will receive written notification of their selection or rejection. Awards will be announced at the annual training conference in **July 2024**.

**AMOUNT:** The Association will designate a maximum of \$5,000 per year for the scholarship program. Additional contributions may increase the amount of funds available each year. The Executive Board will determine the amount and number of scholarships to be awarded each year to individuals who are Regular members of SSCA, their spouse or dependent children and are pursuing either part-time or full-time formal education at the college or graduate school level. The funds will be deposited with an accredited college or university to apply toward the student's tuition and related academic expenses.

#### **ELIGIBILITY:**

- (1) Applicant must be a U.S. Citizen
- (2) Applicant must be an active regular or lifetime SSCA member or a spouse or dependent child of a member.
- (3) Applicant must be pursuing a bachelor or graduate degree in a program of study applicable to the field of criminal justice, rehabilitation, social services or a related field.
- (4) Applicant must be entering his/her freshman, sophomore, junior, senior year or graduate school. Freshman or first year graduate students must be officially accepted in the college or university.
- (5) Applicant must complete the application form, provide all required attachments, and submit the entire package to their State Representative prior to April 1, 2024. The scholarship will be awarded for the next fall term. Incomplete application packages will not be accepted for consideration.

#### ATTACHMENT TO APPLICATION:

- (1) Beginning freshman will submit two (2) letters from high school instructors under whom the student has studied, stating why they support the applicant's receipt of the scholarship award.
- (2) Sophomores, juniors, seniors, and entering graduate students must submit two (2) letters of recommendation from professors under whom the applicant has studied, stating why they support the applicant's receipt of the scholarship award.
- (3) Beginning freshman must submit a certified transcript of their high school grades to date.
- (4) Sophomores, juniors, seniors, and entering graduate students must submit a certified transcript of their college courses and grades to date.
- (5) Graduate students already matriculating in a graduate program must submit a certified transcript of graduate courses and grades to date.
- (6) Beginning freshman and entering graduate students must submit a copy of their official letter accepting them into the college/university.
- (7) On a separate sheet(s) of paper provide a written narrative supporting/justifying his/her need for this scholarship.

#### **COMPLETION REQUIREMENTS:**

- (1) Recipient will only be eligible to receive this scholarship one time.
- (2) Scholarship recipients must forward to the appropriate State Representative a copy of their transcript for the time period the recipient has received the award.
- (3) Failure to satisfactorily complete the semester may result in the recipient being required to repay SSCA the full amount awarded. Satisfactory completion means an overall grade point average of "C" or 2.0 on 4.0 scale for each semester a scholarship was received.
